Ride times will be available via email no later than Thursday before the show. Grass warm-up. Dressage arena on grass or in footed indoor arena at the owner’s choice if bad weather. Jumping will be on a grass warm-up, competition is in all-weather footing. **No individual ribbons for extra jumping rounds.**
